

## **2011 CFHA AGM Minutes**

**1: Introduction and Identification of members present:** Andrea Thiel Secretary, Ron Black Treasurer.

Directors: Carol Boehm, Alison Bakken, Linda Fry, Sheila Kyte, Gunnar Rogstad, Anna Middleton.

**2: Adoption of Agenda:** Bert Davidson moves the agenda be adopted as read.  
Seconded by Geri McNeil

**3: Approval of 2010 AGM minutes:** Gunnar Rogstad motions to adopt the 2010 minutes as read. Second: Aja Johnson.

**4: 2010 Financial Statements:** CFHA treasurer Ron Black read the 2010 fourth quarter income statement and trial balance reports. Ron reminded members present that the current board needs to ask a competent member to audit the 2011 financials for the 2012 AGM.

**5: Accountant for 2011 financial audit:** Carol Boehm recommended that the BoD canvas the eastern members to see if one of them is able to audit the 2011 financials. If no one from the East is found, she also recommended asking Ted Swendson to once again do the audit.

**6: Directors Reports:**

- **2012 Budget projection:** Aja Johnson motioned to adopt the budget projection  
. Second: Mary Kenny
  
- **Website:** Carol Boehm read the report which stated that the association's new webmaster is Sue Kosh. Sue Kosh has the assistance of her son who is a computer game developer and computer programmer. Carol informed members

that she has been working on a non-member commercial vendor account for Norwegian fjord friendly services. She is hoping to help increase the association's newsletter and website revenues as well as help members find products and services that will meet their needs.

- **Auditors Report:** Ted Swendson noted the following in his report.

- Imperative that approval for disbursement of funds be recorded and these records be retained in the records of the CLCR and the CFHA.
- Largest expense to the association are CLRC levies and these charges should be reviewed regularly to analyse to ensure "user pay" principles apply and what steps could be implemented to increase fee recovery.
- 2010 Books of the association show a reasonable cushion but this was partly achieved by donations of various expenses paid by members. While this is a commendable practice it makes year to year comparisons difficult. Ted stated that all expenses be run through CFHA books when people make a contribution equal to the expense. It should then be properly entered and acknowledged.

## 7: Committee Reports:

### A) Promotion committee report:

- Gunnar Rogstad read his report on the Ontario Royal Winter Fair exhibit. He said that our presence there was a success but felt the association should be present for the full ten days because the final Saturday is the big horse show which draws huge crowds. Gunnar reported that they gave out the Breeders Show Case booklet to spectators who said they were looking to purchase Norwegian fjords. Exhibitors Russell Brenneman and Casey Rogstad did a great job as demonstrators. The exhibit was a success thanks to the many volunteers that came and helped man the booth.

- Carol Boehm read the report on the Red Deer and Chilliwack Mane Events. She stressed that volunteers are the face of the association and they have a huge impact on the success of these promotions. Volunteers discovered that spectators at these events were aware that Norwegian fjords made good driving horses but were not as aware of the suitability of Norwegian fjords as sport ponies for dressage, jumping, eventing and trail.
- At all exhibits volunteers were visited by spectators who had unregistered purebred Norwegian fjords. Volunteers invited these owners to join the CFHA and enjoy the benefits of membership.
- Videos of Norwegian fjords performing in dressage, jumping, driving were played on a flat screen television at all exhibits. Breeders Show Case Booklets, brochures, articles, newsletters, membership applications, and non-member newsletter subscriptions were handed out at all exhibits.
- Goals and objectives of the Promotional Committee were read by president Carol Boehm. She stated that the prosperity of the association was dependant on the prosperity of our breeders and members. Therefore the main objective of the promotions committee was to use the association's non-profit status to obtain discounted exhibitors booth space at large equine specific venues. The most economical promotional and educational platform to reach the buying public is at these large exhibits across Canada. The venues chosen had 45,000-350,000 spectators in attendance. Part of marketing is recognizing the demographic market you want to target and then educating your target market as to the advantages of your product. During economic downturns breeders need to aggressively promote and advertise their farms. The Breeders Show Case Booklet handed out to potential buyers at these equine specific exhibits is the best chance they have of educating and positively exposing our breed to the general public. The success of continuing our promotional program is contingent on the advertising support our breeders give future Breeders Show Case booklets, Please take this into account when planning your budget for 2012.

## B) Membership Report:

- As the brand new chair of the Membership Committee, Linda Fry thanked both newsletter editor Jane Beall and fellow Director Gunnar Rogstad for all their work until now. Jane was instrumental in cleaning up the membership list which was somewhat out of date. Linda was pleased to note that we have 15 new members. She and Director Sheila Kyte are putting together an e-mail list of all members by province which will make mass e-mailings much easier.

#### **C) Newsletter:**

- Newsletter Editor Jane Beall reported that the newsletter has grown tremendously over the last year and is now up to 38 pages with colour. Advertising revenue is up as well. Jane asked members to help with story ideas by letting her know of people who do interesting things with their horses: heading south with them, using them in rodeos or as cutting horses or anything else that is interesting.

#### **D) Evaluation:**

- Director Alison Bakken reported that the Evaluation Committee has been working away on record keeping this year. The CLRC is working with us to get the results of the evaluations posted on the pedigree web pages along with a picture.
- A successful Pre-Evaluation and Driving Clinic was held in Nova Scotia at Wallace Point Fjords this spring. Twenty-one Fjord enthusiasts gained more knowledge about the Fjord over two days. An Evaluation was planned for the East Coast although there were not enough horses to make it feasible to hold one this year. We look forward to holding an Evaluation in Nova Scotia in the future.

- The Joint Evaluation Committee with the NFHR has been very educational-it always nice to hear about what works and does not work when holding an evaluation. The experience of the NFHR is a wonderful resource to have at our disposal.
- The Evaluation Committee will look at holding evaluations as hosting parties and the number of horses in an area demand. There may be an evaluation in BC in 2012 and several members expressed an interest in being part of a hosting committee.

## **8: Unfinished Business:**

- Registration transfers: Andrea proposed registration by-law revision clarifying the rules of eligibility for foreign-bred horses. If a horse comes from a recognized foreign registry, the CFHA should accept the registration at face value. A proposed amendment will be presented at the next AGM.
  - Motion was made to charge a \$10.00 fee recovery to those members who send in registration documents with errors or omissions on them. Motion was approved.
  - Motion was made to charge the same recovery fee if DNA testing fails to show parental verification for a foal automatically chosen for such testing according to CFHA by-laws. Motion was approved.
- Uli Schnable: Researched German equine associations that have youth step by step incentive programs. Programs were fun based with the objective of teaching young fjord owners about the value of evaluations, etc. The first incentive program is to be a 2012 photo competition where the pictures will be used to compile a CFHA 2013 calendar.

## **9: New Business:**

- **Correlation between members volunteering and prosperity of Association:** Carol Boehm strongly encouraged members to get involved so that there is enough manpower to manage the Association's affairs. The success of the promotions was due to the involvement of members. We all

have very busy lives but everyone should be able to find an hour or two a year to do their part so that the association exists in future years.

- **Revamping on line registration information:** The CLRC has incorporated the BoD's requested changes to the online pedigree information. Gord Fulton was the liaison between the Board of Directors and the CLRC and pushed these changes to completion. The online pedigree information now includes evaluation results for those horses that were evaluated and the capability to include picture of registered horse with pedigree. The CLRC billed the CFHA \$250.00 to do the layout and inclusion of evaluation results. Inclusion of pictures with pedigree information was done at no cost to association.
- Carol stated that if used correctly these revisions give breeders a marketing tool when promoting their stock.

**10: Next meeting:** Eunice Bosomworth requested we change the AGM date to March. This was discussed amongst members present and the change was agreed to. Our next meeting will be March 2012.
